

## Agreement

This Agreement, made on 8 day of April, 2016 between Shree **District Development Committee Bajura** (hereinafter called "the Employer") and **Galwa Nirman Sewa , Baneshwor Kathmandu** (hereinafter called "the Contractor").

Whereas the Employer is desirous that the Contractor execute **Construction of School Building of Janaparkash Higher Secondary School Kolti-2, Bajura** (hereinafter called "the Works") and the Employer has accepted the bid for **Nepalese Rupees Three, karod fourty nine lakh seventy two thousand two hundred sixty three rupee & fifty paise only (NRs:-3,49,72,263.50)** without VAT by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

Now this Agreement witnesseth as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement. This Agreement shall prevail over all other Contract documents.
  - i. Agreement
  - ii. the Letter of Acceptance
  - iii. the Contractor's Bid
  - iv. the Special Conditions of Contract
  - v. the General Conditions of Contract;
  - vi. the Specification
  - vii. the Drawings; and
  - viii. the Bill of Quantities; and
  - ix. any other document listed in the SCC as forming part of the Contract
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenant with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
5. The Bill payment should be done in form of running bill after receiving instalment from Embassy of India.
6. The work will be completed within 15 months from the date of agreement.
